Professor Lui Tai-lok is the Vice President (Research and Development), Chair Professor of Hong Kong Studies and Director of The Academy of Hong Kong Studies at The Education University of Hong Kong.

Prior to joining the University (the then Hong Kong Institute of Education), he was Professor at The University of Hong Kong (HKU) where he also took up the position of Associate Dean at the Faculty of Social Sciences (2010-2011) and the headship of the Department of Sociology (2011-2014). He has taught at Hong Kong City Polytechnic (1986-88) and The Chinese University of Hong Kong (1988-2009). Professor Lui obtained his B.A. and M.Phil. in Sociology at the HKU and then a Master of Philosophy and a Doctor of Philosophy from Oxford University.

Professor Lui has widely researched and published in topics including class analysis, economic sociology, urban sociology, and Hong Kong society. He also actively contributes to the Hong Kong community by serving on various committees in governmental and professional bodies as well as those related to social services over the years.



Professor CHIU Wing-kai, Stephen

Professor Stephen Chiu obtained his doctorate from Princeton University and is currently Chair Professor in the Department of Social Sciences, and Co-Director, The Academy of Hong Kong Studies, The Education University of Hong Kong.

His research interests include development studies, industrial relations, social movements, youth studies, and the comparative study of the East Asian region. His research also covered many different public policy issues under commission by various public and governmental bodies. He is also active in the community through his public services.

He was the Chair of the Curriculum Committee on Liberal Studies (Senior Secondary) from 2009 to 2016, and had served as the Part-time Member of the Central Policy Unit, HKSAR Government, and a member of the Strategic Development Commission, HKSAR Government.

Dr. Fong Chi-hang, Brian is Associate Director of The Academy of Hong Kong Studies at The Education University of Hong Kong.

Prior to joining the University (the then Hong Kong Institute of Education), Dr. Fong was previously Lecturer in the Division of Social Sciences of the City University of Hong Kong. Before joining the academia, Dr. Fong was an Executive Officer of the HKSAR Government from 2001 to 2007.

Dr. Fong's research interests include China's influences, territorial autonomies, democratization, governance and budgetary politics. He has published extensively in international peer-reviewed journals such as *China Quarterly, Modern China, Asian Survey, Democratization*, and *International Review of Administrative Sciences*. Dr. Fong was awarded the 2014 Gordon White Prize by China Quarterly for his article entitled "The Partnership between the Chinese Government and Hong Kong's Capitalist Class: Implications for HKSAR Governance, 1997–2012".

Dr. Fong is a public intellectual. He is an active commentator for various media and regularly publishes commentaries. He is also very active in community services leading the work of several civil society organizations.

Professor CHU Yiu-wai, Stephen
Professor

Prof. Chu received his PhD in Comparative Literature from The Chinese University of Hong Kong in 1993. He worked for twenty years in the Department of Chinese and Humanities Programme of Hong Kong Baptist University. He was the founding Head of the Department of Humanities and Creative Writing of Hong Kong Baptist University before becoming the founding Director of the Hong Kong Studies Programme at The University of Hong Kong.

Prof. Chu has published more than twenty books, including *Lost in Transition: Hong Kong Culture in the Age of China* (2013), *Hong Kong Culture and Society in the New Millennium: Hong Kong as Method* (ed.; 2017) and *Hong Kong Cantopop: A Concise History* (2017). He has also published widely in journals of different academic disciplines such as literature, film, popular music, cultural policy, anthropology, sociology and legal studies. His research interests focus on Hong Kong culture, postcolonialism and globalization. His most recent work, *Found in Transition: Hong Kong Studies in the Age of China* was published by SUNY Press in 2018.

Professor Annie Chan graduated from Hong Kong University and Oxford University and joined Lingnan University in 1997. Her research areas are gender, sexuality, and personal lives, and her current research projects include singlehood in Chinese cities, female transnational lead migrants and women in Hong Kong's police force. She is currently the President of the Hong Kong Sociological Association (2016-18) and has been past chairperson and long-time active member of the Association for the Advancement of Feminism. She holds concurrent positions as Associate Dean (Social Sciences, Undergraduate Studies) and Warden of one of the ten student hostels at Lingnan.



Professor LEE Shuk-yi, Maggy

Maggy studied at the University of Hong Kong (1983-1989) and the University of Cambridge (1989-1992). She returned to HKU in 2005 and has written extensively on transnational migration (including lifestyle migrants, expatriates and migrant labourers), irregular migration and human trafficking, border policing and criminology of mobilities. Her current research projects include 'Big Data, Live Methods and Surveillance Subjectivities among Transnational Migrants in Hong Kong' (with M. Johnson, Goldsmiths, University of London and M. McCahill, University of Hull, funded by the British Academy) and 'Curating Development' (with M. Johnson, Goldsmiths, University of London and D. McKay, Keele University, funded by the UK Arts and Humanities Research Council). Her books include *Human Trafficking* (Willan) and *Trafficking and Global Crime Control* (Sage).

Thomas Kwan-choi TSE received his PhD degree with a focus on sociology of education at the University of Warwick, United Kingdom in 1997. He is currently an associate professor of the Department of Educational Administration and Policy, the Chinese University of Hong Kong. He teaches and publishes in the fields of values education and sociology of education. His works on education reforms in Hong Kong appear in the books such as Education and Society in Hong Kong and Macau (2nd ed.), Globalization and Education, Education Reform and the Quest for Excellence, Remaking Citizenship in Hong Kong, Globalisation, the Nation-state and the Citizen, and Making Sense of Education in Post-Handover Hong Kong.

His main research interests include modern Chinese and Western intellectual thoughts, Western historiography and historical theories, Sino-Western cultural exchange, Sino-German relations and Chinese Martial Arts Traditions.

Francis Lee is Director and Professor at the School of Journalism and Communication in the Chinese University of Hong Kong (CUHK). He is currently chief editor of *Chinese Journal of Communication* and associate editor of *Mass Communication & Society* in addition to serving on the editorial boards of several notable communication studies journals. Dr Alistair FRASER
Senior Lecturer

The University of Glasgow

Alistair Fraser is Senior Lecturer in Criminology and Sociology at the University of Glasgow, and Associate Director of the Scottish Centre for Crime and Justice Research. His work focuses on youth violence, street culture, and urban ethnography, with a particular interest in youth 'gangs'. Alistair's first book, Urban Legends: Gang Identity in the Post-Industrial City (OUP, 2015) was shortlisted for the BBC/BSA Ethnography Award and co-awarded the British Society of Criminology Book Prize. His most recent book, Gangs and Crime: Critical Alternatives was published by Sage in 2017. From 2011-2015, Alistair was Assistant Professor in Criminology at the University of Hong Kong, where he received the Faculty of Social Sciences 'Outstanding Teaching Award' for 2013-14. He maintains a keen interest in issues of youth, crime, and urban space in Hong Kong and in critical Asian studies more broadly.



Dr LI Eva Cheuk-yin

Eva has an interdisciplinary background. She holds a PhD in Gender, Media, and Culture (King's College London), MPhil in Sociology (The University of Hong Kong), and Bachelor of Social Sciences (First Class Honours, The University of Hong Kong). She is specialised in the study of media and culture, gender and sexuality, and fandom and audience reception in the East Asian and transnational contexts. She is currently working on a monograph on Chinese women's everyday practice of zhongxing (lit. 'middle gender/sex' or 'neutral gender/sex') based on her award-winning doctoral dissertation, as well as several articles on Asian popular culture and queer politics. To date, her articles have appeared in books, encyclopaedias, and refereed journals.

Lisa Y.M. Leung is an associate professor at Department of Cultural Studies, Lingnan University. She received her PhD in Media Studies at the University of Sussex. She has researched into and published extensively on the global circulation of East Asian popular culture, with the Korean Wave as case study. Another major research area is ethnic minority discourses and multiculturalism, as she co-authored a book titled 'Understanding South Asian Minorities in Hong Kong' (2014). She has also published in the area of television and media studies. She is currently focusing on the role of social media in social movements, establishing relationships between affordances, affect and media spatiality.

After completing her undergraduate studies in Russian and English language and literature with a pathway in modern history in Venice, she moved to Manchester to complete her postgraduate studies in European and Soviet history under the guidance of Peter Gatrell, who has pioneered research on the global history of refugees. Since September 2007, she has been with the School of International Studies, at the Chinese campus of the University of Nottingham, and gradually expanded her research interests to include children, migration, and social policy in Asia (including social policy in emergencies). She is currently researching the politics of international humanitarian assistance to unaccompanied and refugee children in post-war Europe and Asia in the context of the Cold War and global imperial rivalries.

Professor Daniel T.L. Shek is Associate Vice President (Undergraduate Programme) Chair Professor of Applied Social Sciences, and Li and Fung Professor in Service Leadership Education at The Hong Kong Polytechnic University. Professor Shek has to date published 144 books, 394 book chapters and more than 650 articles in international refereed journals. He is the Chief Editor of *Journal of Youth Studies* and *Applied Research in Quality of Life*, Associate Editor of *Frontier in Child Health and Human Development* and past Consulting Editor of *Journal of Clinical Psychology*. Professor Shek is a psychologist with research interests in positive youth development, family process, scale development, quality of life, program evaluation, addiction and spirituality. Professor Shek has been awarded many research grants by the Research Grants Council. His research project on the adjustment of Chinese people to midlife has been rated "excellent" by the Research Grants Council.

Wai-man Lam researches identity politics, political culture and political participation. She is the author and coauthor of two books, and coeditor of three existing volumes on Hong Kong politics including the latest one on the Umbrella Movement (*Citizenship, Identity and Social Movements in the New Hong Kong: Localism after the Umbrella Movement*, Routledge 2018). She has also published articles in journals such as *PS: Political Science and Politics, The China Quarterly, Social Indicators Research, Citizenship Studies*, and elsewhere. Her more recent and significant works include three book chapters respectively on brands of localism in Hong Kong (Routledge 2018), changing political activism in Hong Kong (Palgrave Macmillan 2018), and the belief in the rule of law and its resilience in the Hong Kong political identity (Hart/Bloomsbury forthcoming).

His research interests include post-WWII graphic forms, literary journalism, Indian English fiction, and Hong Kong Studies. He has articles forthcoming on reflexivity in A Suitable Boy, and irony in R Crumb. His monograph is titled Smiley, Franzen, DeLillo: Narratives of Everyday Justice. He has two creative nonfiction books: Refrain and Cemetery Miss You. He is co-editor of the essay collection Cultural Conflict in Hong Kong: Angles on a Coherent Imaginary.

Wendy Siuyi Wong is professor in the Department of Design at York University, Toronto, Canada. She has taught in Hong Kong, the United States and Australia, and has established an international reputation as an expert in Chinese graphic design and comic art history. She is the author of *Hong Kong Comics: A History of Manhua*, published by Princeton Architectural Press. In 2009 and 2010, she was a visiting research fellow at the Department of Design History, Royal College of Art, and she served as a scholar-in-residence at the Kyoto International Manga Museum. She is a contributor to the *Bloomsbury Encyclopedia of Design* and acts as Greater China Region editor for Bloomsbury Publishing's *Encyclopedia of East Asian Design*. Her latest book, *The Disappearance of Hong Kong in Comics, Advertising and Graphic Design*, was published by Palgrave Macmillan in 2018.



Dr John D. WONG

Dr Wong's research focuses on the flow of people, goods, capital and ideas. With a particular interest in Hong Kong and the Pearl River Delta area, he explores how such flow connected the region and its residents to the Chinese political center in the north as well as their maritime partners in the South China Sea and beyond. Studying the China trade in the context of early-nineteenth-century global exchange, his first monograph, *Global Trade in the Nineteenth Century: The House of Houqua and the Canton System*(Cambridge University Press, 2016), demonstrates how China trade partners sustained their economic exchange on a global scale long before Western imperialism ushered in the era of globalization in a Eurocentric modern world. He has published in various academic journals including *Business History Review, Law & Literature*, and *Asia Major*.

(1) The Second Life of Kowloon Walled City: Crime, Media and Cultural Memory

Kowloon Walled City (hereafter KWC or Walled City), Hong Kong has been described as 'one of history's great anomalies'. The territory remained under Chinese rule throughout the period of British colonialism, with neither jurisdiction wishing to take active responsibility for its administration. In the postwar period, the area became notorious for vice, drugs and unsanitary living conditions, yet also attracted the attention of artists, photographers and writers, who viewed it as an instance of anarchic urbanism. Despite its demolition in 1993, KWC has continued to capture the imaginations of successive generations across Asia. Drawing on data from an oral and visual history project on the enclave, alongside images, interviews and observations regarding the 'second life' of KWC, this article will trace the unique flow of meanings and reimaginings that KWC has inspired. The article will locate the peculiar collisions of crime and consumerism prompted by KWC within the broader contexts in which they are embedded, seeking out a new interdisciplinary perspective that attends to the internecine spaces of crime, media

(2) Online Radio Listening as 'Affective Publics'? (Closeted) Participation in the Post-Umbrella Movement Everyday

The porosity of the online media space blurs the boundary between the political, the popular and the social. While most media scholarship concentrates on the 'DIY participation' that the internet enables, it overlooks the fact that most of the users are just consumers of the array of political platforms. Employing Ranciere's notion of the aesthetics of the everyday and using the case of online radio listening, the paper reexamines the politics of participatory practices in the politicized everyday, as the audience traverses fan practices and quotidian virtual activism. This paper focuses on elderly and female listener communities, to discuss how the porous social mediascape may foster a 'participation of the sensible', where 'the ordinary' engages in online radio listening as subversive act against the government, but also calculated political AND social strategy against the harshening political reality and social division. The case of Hong Kong would also hope to articulate the nuanced interplay between media participation and the politically divided juncture.

(3) Chinese Refugee Children and Empires: The Politics of International Adoptions in Cold War Hong Kong

With the support of new sources from British and Hong Kong archives, this study casts new light on the post-war international adoptions of Chinese refugee children in the British colony of Hong Kong. It argues that while children were 'saved' and found families overseas, they were also used as pawns in a bigger political game. A way to delegate welfare for the Hong Kong government, a symbolic humanitarian concession vis-à-vis a strict anti-immigration policy for Britain, and an anti-communist propaganda tool for the United States, these adoptions also convey the competing power and population politics played over subject children by two multiracial empires: one in decline (the rapidly decolonising Britain), the other on the rise (the new cold war superpower).

(4) Trajectories of Personal Well-Being Attributes among High School Students in Hong Kong

How personal well-being of adolescents changes over the high school period is not entirely clear in the scientific literature. Using 15 positive youth development (PYD) attributes as indicators of well-being, the current study investigated the related developmental trajectories among a large sample of Hong Kong adolescents from Grade 7 to Grade 12. Individual growth curve modeling revealed that while variation existed across different PYD attributes, nine out of 15 positive youth development attributes declined in the early adolescence but showed a rebound or a slower rate of decline in the late adolescence. The current study serves as a pioneering attempt to chart the normative profiles of Chinese adolescents' personal well-being over time. The theoretical and practical implications of the findings are discussed.

(5) Investigating the Differential Mobility Experiences of Chinese Cross-border Students

Recent migration studies have adopted the lens of mobility to examine the stratifying effects of border policies, but few investigate the differential mobility of migrant families and children. This paper aims to contribute to the migration literature by considering the interplay between border policies, family configurations, and differential mobility. We apply the lens of differential mobility to the experiences of Chinese cross-border pupils – young child migrants with Hong Kong permanent residency who reside in Shenzhen, China, and cross the border to attend school. We begin by describing shifts in Hong Kong's border and immigration policies since 1997, which have created a typology of families differentiated by mixed status, citizenship rights, and mobility. We then turn to four case studies of students with unequal border-crossing experiences to elucidate how border control constrains or promotes family mobility and perpetuates inequalities.

(6) Mothers' Experiences of a Voucher Scheme within the Context of Hong Kong's Early Education: Issues of Affordability and Justice

This paper examines issues of affordability and justice using the concept of "basic structure" as developed by Iris M. Young in order to produce a more nuanced account of the Pre-primary Education Voucher Scheme. We draw on the experiences of Hong Kong mothers of different socio-economic status who have participated in the voucher scheme. The scheme aims to provide affordable quality early education by giving parents a flatrate voucher so as to assist them in enrolling their children in non-profit local kindergartens. We base our arguments on the central premise that socially just policy requires meticulous attention to the basic structure that determines distributive patterns. We go on to argue that the basic structure is governed by institutional assumptions, rules, and practices about class, gender, and markets. Our analysis references both quantitative and qualitative data of a three-phased mixed-method study with > 1400 mothers. The key findings reveal how mothers of different socio-economic backgrounds experienced the voucher scheme where power structures and relations are legitimized, thus contributing to the structural processes that reproduce constraints and injustice. Mothers' articulation regarding the policy recommendation of free early education adds insights into the constraints they experience and a notion of collective responsibility in supporting the education of young children.

VII. Abstracts of HKS Research School Papers

Mobility and Identity: Based on the Data of HKPSSD2013 in Hong Kong China

ZHENG Wanging Sun Yat-sen University

Intergroup contact theory proved that intergroup contact reduce prejudice. In this paper, we use the data from HKPSSD to analyze the influence of Hong Kong residents' cross-border flow on the Chinese identity. At the beginning, cross-border flows can indeed improve the Chinese identity of Hong Kong residents. But as the Hong Kong people cross the border more frequently, their Chinese identity becomes weaker. The result shows that the influence of cross-border flow on the identity is non-linear. When the frequency of cross-border exceeds a certain point, the Chinese identity will no longer increased. It seems that the optimal distinctiveness model can explain the fact. Social identity can be viewed as a compromise between assimilation and differentiation from others, where the need for deindividuation is satisfied within in-groups, while the need for distinctiveness is met through intergroup comparisons. The deeper the Hong Kong people experienced difference from mainlander, the more difficult for them to integrate different identities.

A "Constitutional Experiment" before and after the Great Squatter Fire: the Vesting of Public Housing Responsibilities in the Urban Council of Hong Kong, 1948-54

CHUI Wing-kin

During the post-war era, British Hong Kong was famous for its two characteristics: rapid modernization without self-governance (i.e. complete democratization) and an enormous public housing programme. This article answers one question: Why did the colonial government, before and after the Shek Kip Mei Squatter Fire, entrust low-cost housing and squatter resettlement responsibilities to the Urban Council, the only institution with elected members in the then crown colony constitutional system? Housing affairs were proper municipal responsibilities. In Metropolitan Britain, public housing matters were under the municipal authorities' control; in Hong Kong's port-colony counterpart, British Singapore, a municipality was indirectly involved in such functions. It was natural and logical that the Hong Kong Government followed England and Singapore's practice when it had to commence a public housing programme, which was completely new to the colony. Nevertheless, many colonial officers and business figures were sceptical to such partially elected institution and the politicians therein, and hence opposed the proposal of granting public housing functions to the Council. However, their oppositions were ignored, as Governor Alexander Grantham intended to implement a "minor constitutional change" after the major one had been shelved indefinitely. In addition, with public housing functions being vested in the Council, the government could win the Councillors' support and keep itself informed of public opinion regarding housing affairs. It helped to stabilize colonial rule, which could be vulnerable to internal and/or external threats stemming from Chinese nationalism, communism and the global wave of anti-imperialism and decolonization.

The Rule of Law and the Chinese Litigants in Hong Kong from the 1840s to the 1940s

"The rule of law" has long been celebrated as the foremost legacy of the British imperial administration in Hong Kong, but recently these laudatory remarks are under considerable challenge. Some scholars argue that, under the authoritarian colonial government, especially in the first century of British rule, the law only served as an "instrument" of the British government for its promotion of policies and control of the indigenous Chinese population, and it is simply impossible to imagine the existence of "the rule of law." But oddly, many cases also seemed to show that "the rule of law" was not a sheer "myth" in colonial Hong Kong, especially when it comes to the judicial administration, which sometimes frustrated the authoritarian tendencies, imposed certain restrictions on the arbitrary power of government and even became an "arena" that enabled the indigenous Chinese to negotiate with the British rulers in the sphere of law. The purpose of this article is to rethink "the rule of law" in colonial Hong Kong through the lenses of "law" and "colonialism." Firstly, I sketch these two contradictory attitudes toward "the rule of law" in colonial Hong Kong. Secondly, I put this debate into the broader study of law and colonialism. Thirdly, I move from the debate to the examination of the conception of "the rule of law" itself, which is a crucial notion in all these discussions. Finally, I conclude with a reconsideration of "the rule of law" in colonial Hong Kong.

Lady Justice or The Golden Calf? The 'China Factor' in Hong Kong's Legal Sector

LAI Yan-ho

The concept of 'China factor', which is derived from the work of the Taiwanese scholar WU Jieh-min, refers to the political strategy of People's Republic of China (PRC) over other regions and countries by creating the latter's economic dependence. The purpose of this paper is to test the impact of 'China factor' by evaluating PRC's political economic strategy in the legal sector of Hong Kong, and its political, economic and legal-cultural impacts. This paper argues that, apart from direct institutional intervention of PRC since the handover, the legal sector of Hong Kong also faced a gradual process of collaboration, motivated by economic developments of Hong Kong and Mainland China. PRC uses different tactics to influence the orientation of development of various legal institutions, in order to consolidate the economic ties between legal service sector of Hong Kong and the commercial sector of PRC. The tactics include collaboration with legal professional societies and law schools, nurturing organized pro-establishment lawyers and offering business opportunities to young lawyers and undergraduate law students in Mainland China. Such economic ties pose impacts of the political behaviours of individual and organized legal profession in Hong Kong. While there are lawyers and legal scholars vocally engaging in

defense of human rights and the rule of law in Hong Kong, a network of legal profession promoting a 'skinny rule of law' and Chinese legal values emerges. The significance of 'China factor' over the culture and practice of the rule of law in Hong Kong will be evaluated at the end of this paper. Methodologically, semi-structured elite interviews with academic lawyers, practicing lawyers and law students, and content analysis on published materials of various legal associations and institutions are adopted.

The Construction of Social Identities of Hong Kong Students in Tertiary Education in Mainland China

PAN Xiaochun The Chinese University of Hong Kong

It aims to investigate how the cross-bordering tertiary education experiences shape the configuration and, transformation of social identities of students who are holding Hong Kong (Permanent) Identity Card, and seeking their tertiary education in the universities in Mainland China. Specifically, the objects of the research includes "Authentic Hong Kong residents" ("真"香港人) or "Hong Kong residents in practice" and "Inauthentic Hong Kong residents'("假"香港人) or "Institutional Hong Kong residents" who are holding HKID card while living in Mainland China for most of their lives. Besides, the social identities refer to identification with "Hongkongnese" and "Chinese". It should be noted that identities of "Hongkongnese" and "Chinese" are not necessarily contrary, and it is common that they hold the dual or mixed identities of Hongkongnese and Chinese. There may be some differences in their perceptions about Hong Kong and China, and identification with Hongkongnese and/or Chinese. Thus this paper explores the status quo of cross-bordering college students' social identities and the meanings of their identities, which are mainly based on two dimensions of local-national, and ethnic/cultural-political/civic. In addition, it also examines whether there are changes of their identities and the reasons for change, if any. It adopts in-depth interviews to collect the data in Guangzhou and Beijing, including their cross-bordering experiences, perceptions about Hongkong/Mainland China and their people, their identification with Hongkongnese and/or Chinese, citizenship in the context of trans-bordering migration (that is, Hongkongnese in mainland China). After collecting the data, it will adopt the methods of category analysis and discourse analysis to analyse the data.

The Impact of Civic Media on Non-conventional Political Participation in the Post-mobilization Period: Hong Kong University Students' Case

Marta SOLER ALEMANY Waseda University

This research analyzes the impact of "civic media", defined in this study as the political usage of online informative sources -mainly alternative media consumption and socio-political networking- on youth for non-conventional political participation. Particularly, online participation such as expressing political opinion online. Based on social capital, public sphere and social mobilization approaches, this study focuses on the postmobilization period in Hong Kong, referring to the period when the protests or occupations were over. In this case, the so-called Umbrella Movement occurred in 2014.

The research question is: what are the effects of civic media usage on nonconventional political participation in the post-mobilization period? The methodology utilized is a quantitative analysis, based on a Structural Equation Modeling (SEM), of 506 respondents sample from a questionnaire develop for Hong Kong students. The results show that civic media increases both, a) desire for involvement into political causes and decision-making, considered as a mediator, and b) non-conventional political participation. However, since desire for involvement does not lead to nonconventional political participation, civic media alone might not be sufficient to cause participation. There are probably other factors conducive to it that need to be considered for further research. For instance, satisfaction with Government, threats to national identity or feeling powerless in politics. This paper represents a contribution to media studies, social movements, Hong Kong regional studies as well as a call for theory development.

Tea in Hong Kong: A Historical and Literary Exploration

GOH Cheng-fai Zach Hong Kong Baptist University

Most of Hong Kong's history books will no doubt have a chapter (or more) dedicated to the origins of the city as a former colony, gained by the British through the illicit sale of opium to offset their growing addiction for tea from China. However, this paper explores the narratives that surround the construction of this historical period, by examining Anglophone literary works about Hong Kong as a form of cultural representation that demonstrates Hong Kong's tea culture. I seek to explore the construction of tea's role as a social and ritual beverage, and a commodity in the global market, in historical and fictional Anglophone narratives about Hong Kong. By doing so, I hope to draw attention to Hong Kong's own tea culture, something that has not been examined exclusively at this moment. The foodways of tea, postcolonial identity formation in historical and literary narratives, and cultural semiotics are some of the possible avenues for such research. The meaning of tea in Hong Kong culture is tool for understanding an aspect of Hong Kong's history, and the history of transmission of tea from a Chinese beverage into a global commodity that plays an important role in world history. This paper attempts to present a literary history of the key role and function of tea as a social and ritual beverage in Hong Kong. The Hong Kong focus provides a starting point for the discussion of historical maritime trade routes and cultural migrations for China to Southeast Asian British colonies. The contrast and tense proximities between the overseas Chinese and the British provide a fertile discussion of postcolonial issues of hybridity and identity formation among the overseas Chinese in diaspora. Hong Kong's role as a pivot and a starting point for this maritime trade for tea will be emphasized.

Wong Kar-wai's Jiang Hu and Identity in The Grandmaster

Asia rises when Asia engages in multiple inter-referencing. The prerequisite is to first identify and excavate the "base-entity" of a culture, which has to be overcome for transcendence, according to Chen Kuan-hsing. However, the temptation to include in

enunciating such base-entity is enormous. The rise of China seems to signify an insidious, slippery regression into essentializing her own base-entity and thereby muting the multitude. In view of this, this paper aims to reveal that Wong Kar-wai's career is a struggle to transcend such regression. His status as an era-defining auteur resides in how he masterfully uses his jiang hu as method to reimagine the identity and subjectivity of the people in Hong Kong and beyond. Before The Grandmaster (2013), Wong's jianghu had always been an allegory of the nativization of a fetishized identity. A lost love, usually as a primordial, archetypal and absent femme fatale, represents a perfect, imaginary past that the protagonists want to repeat but in vain. In 2013, Wong woke up from the obsession with base-entity and realized that the wushu jiang hu, the martial art universe in Ip Man's time, could be a method to reimagine Hong Kong, beyond the present deadlock that involves seemingly opposing forces, like localization, globalization, neo-liberalization and mainlandization. In the inheritance of different martial art traditions during troubled times, Wong sees Hong Kong's vitality in cultural hybridization. After the long years of chasing la femme fatale, Wong enunciates an identity of essence-transcending family resemblance.

The Image of the PRC in Liberal Studies for Senior Secondary Level - Curriculum and Reference Book Analysis

Katarzyna GUILLON University of Warsaw

Liberal Studies (LS) for senior secondary level have been largely discussed in the context of young people's engagement in pro-democracy or even pro-independence movements in Hong Kong Special Administrative Region (HKSAR). However, it is also one of the most important subjects within the national education in the territory.

The article covers a part of the author's doctoral research on the national education in post-colonial Hong Kong. It aims to present the image of the People's Republic of China (PRC) created by the LS curriculum and Hong Kong Educational Publishing Company reference book for Modern China module. Fallowing research questions will be posed: which elements aim to reinforce national identity and national pride? How are the negative aspects of the PRC's situation presented in the sources? Which ways do the authors try to reassure the students who might be anxious about further integration between HKSAR and Mainland China?

Both content and form, including visual aspects (pictures, tables, layout) are analyzed. Special attention is given to the reference book chapter consecrated to the country's governance. Several analysis methods are employed, including some of the tools used by the researchers specialized in critical discourse analysis or social.

VII. List of Papers Reviewed
