Terms of Reference

- 1. To investigate and decide on any appeal by a student against the decision of the Student Disciplinary Committee or the Board of Examiners for his/her discontinuation of studies.
- 2. To investigate and decide on any appeal against the decision of the Equal Opportunities Complaint Committee on the case(s) in which the Respondent is a student.
- 3. To cancel, alter or impose additional penalties as it deems appropriate on the student(s) appealing against the decision of a student disciplinary case.
- 4. To decide whether the student should be required to discontinue his or her studies for a case where the student is appealing against the decision of a Board of Examiners and to recommend appropriate measures if the decision is to allow the student to continue.
- 5. To decide whether or not to adopt the findings and recommendations of the Equal Opportunities Complaint Committee, and to decide on the appropriate course of action, as deemed necessary.
- 6. To inform the Board of Examiners or the Student Disciplinary Committee or the Equal Opportunities Complaint Committee concerned and the student concerned as soon as possible of its decision and recommendations.
- 7. To report to the President at such intervals as the President may decide.
